### Rules, Recommendations, and Information

Only one dog per ticket holder. Any participating dog must be at least 6 months old. All dogs will be admitted free of charge. All dogs must have complete and current vaccinations. We reserve the right to refuse entry to any dog. Waiver form must be completed before tickets will be issued. We reserve the right to direct you and your dog to any seat in our outfield berm area. Dogs and their owners will be restricted to the outfield berm area within the ballpark. Your dog must wear a current rabies tag to gain admission to the park. ID tags are recommended. All dogs MUST be on a leash at all times. Use good judgment regarding the temperament of your pet so that this event will be enjoyable for everyone. Do not bring your dog if it is unreliable in crowds or with other dogs or has a history of biting or violence. DO NOT BRING A DOG WHOSE BEHAVIOR COULD BE DANGEROUS TO OTHERS. Be courteous and responsible – please comply with our request that you pick up after your dog.

### Waiver and General Release of Claims and Covenant Not to Sue

I, the undersigned, fully understand, appreciate and agree that I have voluntarily requested to participate in an event entitled “Bark in the Park at Baum-Walker Stadium”, which will involve my attendance and the attendance of my dog, of which I have custody, at Baum-Walker Stadium (“Event”). I understand that by participating in this Event, my actions may result in serious anticipated and/or unanticipated injuries (including without limitation bites, fractures, bone breaks, sprains, concussions, illness, disfigurement, dismemberment, paralysis and death), as well as and damage to myself, others, my property or the property of others, injury, illness or death to my dog or the dogs of others, and all associated costs, attorney’s fees and expenses (“Injuries or Damages”). I hereby represent that the dog of which I have custody during the event is in good health, has no prior history of biting or violent behavior or conditions which could interfere with its ability to safely participate in the Event. I confirm and assure that the dog has current rabies vaccinations. I agree to abide by any decision of any University official concerning my ability or the ability of the dog of which I have custody to participate in the Event safely, and I further agree that University officials may authorize necessary treatment for me and/or the dog in my custody.

I hereby give consent for any medical treatment that may be required, as determined by a medical professional at the medical facility, during my participation in the Event with the understanding that the cost of any such treatment will be my responsibility. I agree to indemnify and hold harmless the Board of Trustees of the University of Arkansas, its current and former Trustees as well as all University of Arkansas officers, students, volunteers, subcontractors, representatives and employees ("Released Parties") for any costs incurred to treat me, even if a Released Party has signed hospital documentation promising to pay for the treatment due to my inability to sign the documentation. I further agree to release, waive, discharge, covenant not to sue, and agree to hold harmless for any and all purposes, Released Parties from any and all liabilities, claims, demands, Injuries or Damages that may be sustained by me or my dog while receiving medical care or in deciding to seek medical care, including while traveling to and from a medical care facility, including injuries sustained as a result of the sole, joint, or concurrent negligence, negligence per se, statutory fault, or strict liability of the Released Parties.

I assume and any and all risks associated with my participation in the Event, including, but not limited to, risk of or associated with Injuries or Damages traveling to and from the event, falls, contact with others at the event, Injuries or Damages sustained by and through other participant dogs, the effects of the weather, including, but not limited to, extreme temperature and/or humidity, the condition of the premises and Baum-Walker Stadium, including, but not limited to, sidewalks and parking lots. I understand and agree that all such risks are appreciated and voluntarily assumed by me. I agree to abide by all applicable University policies and rules and instructions given in connection with the Event. I assume the risk for Injuries and Damages sustained as a result of the manner and method by which the Event is administered. I acknowledge that I have completed the "Bark in the Park at Baum-Walker Stadium 2019" form, I understand that I am solely responsible for the accuracy of information that I have provided, and I hold the Released Parties harmless and agree to indemnify them from liability and any responsibility for the information contained in the form and verifying such information regardless of whether the information was provided by me or a third party.

I, the undersigned, have read this waiver and I am competent to sign the waiver with full understanding of the above information. In consideration for allowing me to participate in this event with the dog in my control, I hereby for myself, my heirs, executors and administrators or anyone acting on my behalf, waive, release, covenant not to sue and fully indemnify and hold harmless and discharge the Released Parties from any and all claims, demands or causes of action of any kind arising out of or related to any Injuries or Damages related to my presence on University property and participation in this Event regardless of who causes the Injuries or Damages sustained and regardless of whether such Injuries or Damages arise from any negligent or intentional acts or omissions.

I further grant the University of Arkansas, Fayetteville's Athletic Department the perpetual, royalty-free, worldwide right to use for publicity or promotional purposes, my name and/or pictures of me and my dog or dogs in any media without and liability or obligation to me.
